This Memorandum of Understanding (MoU) is made and entered into on 05-04-2025, by and between St. Joseph's Training College, Pavaratty, an institution dedicated to teacher education and Sanjos Public School, Pavaratty an educational institution committed to providing quality school education.

1. OBJECTIVE

The purpose of this MoU is to establish a formal understanding between the College and the School for facilitating the placement of trained teacher trainees from the College in teaching positions at the School, thereby enhancing career opportunities for students while addressing the staffing needs of the School.

2. SCOPE OF COLLABORATION

a) The School agrees to consider eligible and qualified graduates from the College for teaching positions based on their merit and suitability. b) The College shall provide the School with a list of prospective candidates, along with their academic credentials and performance details. c) The School shall conduct interviews and selection processes as per its internal policies and requirements. d) The selected candidates will be placed in suitable teaching positions at the School as per the terms agreed upon by both parties. e) Both institutions shall engage in mutual collaboration for faculty development programs, workshops, and seminars related to pedagogy, curriculum development, and educational research.

3. RESPONSIBILITIES OF THE COLLEGE

a) To ensure that students recommended for placement possess the requisite qualifications, skills, and competencies required for the teaching profession. b) To facilitate necessary training, internships, and workshops that prepare students for school teaching roles. c) To coordinate with the School in scheduling interviews and placement-related discussions. d) To provide necessary documentation, including academic transcripts and letters of recommendation, if required.

4. RESPONSIBILITIES OF THE SCHOOL

a) To provide job opportunities for selected students based on merit and institutional requirements. b) To conduct a fair and transparent selection process, including interviews and practical assessments if necessary. c) To mentor and guide newly recruited teachers in their initial phase of employment. d) To provide necessary feedback to the College regarding the performance of placed candidates for continuous improvement of training programs. e) To explore possibilities of collaborative activities like guest lectures, teaching demonstrations, and faculty exchange programs.

5. DURATION AND TERMINATION

This MoU shall remain in effect for a period of one (1) year from the date of signing unless extended by mutual agreement. Either party may terminate this MoU with a prior written notice of three (3) months, citing valid reasons.

6. GENERAL TERMS

a) This MoU does not create any legal obligation for recruitment but serves as a framework for cooperation. b) Any amendments or modifications to this MoU shall be made in writing and signed by both parties. c) Any disputes arising from the implementation of this MoU shall be resolved amicably through mutual discussion.
